## Health Care Decisions

A Living Will is a legal document which states your wishes concerning your FUTURE health care when you are unable to speak on your own behalf. A Living Will is used to ensure that the medical care you receive in the future is the kind of care YOU would have wanted, if you had been able to speak directly to your doctor.

A Health Care Proxy is a document recognized by Law, which allow you, a competent adult, to appoint another trusted person to make health care decisions for you in the event you are unable to convey your wishes directly with your doctor.

The Health Care Proxy may be general or very specific.

## Financial Decisions
